ORDINANCE NO. 2022-02

AN ORDINANCE OF THE BOROUGH OF LOGANVILLE, AMENDING ORDINANCE NO. 2008-03, PROHIBITING THE OPERATION OF VEHICLES, PARKING AND OBSTRUCTIONS ON SIDEWALKS IN THE BOROUGH

WHEREAS, Loganville Borough Council adopted Ordinance No. 2008-03, Prohibiting the Operation of Motor Vehicles, Parking and Obstructions on Sidewalks in the Borough; and

WHEREAS, Borough Council desires to adjust the fines and penalties for violation of Ordinance No. 2008-03.

IT IS, THEREFORE, ORDAINED AND ENACTED by the Borough Council of Loganville Borough, as follows:

SECTION 1. Section 5 of Ordinance No. 2008-03 shall be amended by deleting the words that are struck through and adding the words that are underlined as follows:

SECTION 5: Penalties and Violations. Penalties and Violations. Any person violating any part of this Ordinance shall pay fine of one hundred fifty (\$150.00) dollars ~~fifteen (\$15.00) dollars~~, as well as attorney's fees and costs of prosecution or in default of payment of the fine, ~~shall be committed to the County Prison for not more than ten (10) days.~~ Each day's continuance of violation of this Ordinance shall constitute a separate offense.

In addition to any applicable penalties or costs, any person who violates this Ordinance shall pay to Loganville Borough an administrative charge for each notice of violation sent. The charges are set forth below, and may be modified by subsequent Resolution of Loganville Borough Council:

<u>First Notice of Violation</u>	<u>No charge</u>
<u>Second Notice of Violation</u>	<u>\$100.00</u>
<u>Third Notice of Violation</u>	<u>\$100.00</u>
<u>Additional Notices</u>	<u>\$100.00</u>

When a repeat violation occurs, the Borough may proceed immediately to remedy the violation per Section 3 of this Ordinance or provide notice to the owner of the violation. Such notice may allow the Owner time to cure the violation or indicate the action that is or must be taken.

SECTION 2. All provisions of any previous Ordinances inconsistent with the provisions of this

SECTION 3. Effective Date. This Ordinance shall become effective immediately.
