Loganville Borough Mayor's Report – March 2024

Mayor Report Summary:

- Pennsylvania State Police (PSP) Report: none received

- Emergency Management (EM):

- Fire Police Requests: none received
- Weather Emergencies:

- York County Office of Emergency Management (OEM) provided numerous National Weather Service weather briefings throughout the month, of which the most significant were passed to Borough Council (BC).

- York County OEM Duty Officers provided county wide WebEOC incident report number 10184 on Tuesday, February 13 for Winter Storm (WS) Lorraine, due to its impact county wide. In collaboration with the BC President, I had already made a Snow Emergency Declaration (SED) at 9PM on Monday, February 12 to remain in effect until noon on Tuesday, February 13. Several ordinance violation warning letters were issued for parking on borough streets when the SED was in effect.

- On Friday, February 16 at 6PM, I issued another SED after receipt of a WS Warning (unnamed storm) which was in effect until noon on Saturday, February 17. Only four ordinance violation warning letters had to be issued for parking on streets when this SED was in effect.

- Meetings/Training:

- York County OEM will hold Quarterly EMC Training at the York County Coroner's Office (attached to York County Prison), 3400 Concord Road, York on Thursday, January 11th from 6:00-8:30 PM. We will tour the facility, receive a presentation on the duties of the Coroner's Office and learn how it specifically applies to EMCs.

- Correspondence:
 - An email from the York County Planning Commission (YCPC) was received on Friday, February 2 informing Municipal Hazard Mitigation Representatives and Municipal EMA Coordinators that due to delays in completing a draft of the York County Hazard Mitigation Plan (HMP), that the YCPC needs to reschedule the public meeting that was originally scheduled for February 20, 2024. Once a complete draft of the HMP is ready, the YCPC will provide a new meeting date and 45 day review period announcement.
 - An ordinance violation letter was mailed on Thursday, February 8 for violating the Grass and Weeds Ordinance (No. 2006-02), as they were protruding onto a borough street and scratching vehicles or endangering pedestrian and vehicular traffic. The letter was received on Saturday, February 10 and the property owner resolved the issue the next week.
 - On Thursday, February 15, I received an update letter from the US Department of Housing and Urban Development (HUD) regarding an ongoing issue dating back to September 2023. I subsequently provided this letter to the BC President.
 - On Saturday, February 24, I was informed that borough residents made complaints about the appearance of a particular property due to junk and other miscellaneous materials in the yard. At the end of the month, I made a visit to address this with the property owners, but no one was home at the time. I will follow up in March.
- Miscellaneous:
 - At the February BC Meeting, I was asked to contact Scouts BSA Troop 50 regarding damage to the recently installed fencing in the Goodling Park parking lot, which was damaged during WS Indigo. A Troop 50 Eagle Scout Candidate had installed this fencing for his Eagle Scout Project. I contact the T50 Scoutmaster (SM) on Thursday, February 8 to see if T50 could make repairs. The SM replied on Tuesday, February 20 suggesting that after the ground thaws, T50 would take on the repairs as a community service project provide that they are only responsible for the labor and that the Borough would provide or reimburse for posts, concrete and pother expenses incurred for completion of the project.
