# **Mayor Report Summary:**

- Pennsylvania State Police (PSP) Report: none received

- Emergency Management (EM):
  - o Fire Police Requests: none received
  - Weather Emergencies:
    - The York County Office of Emergency Management (OEM)
      provided numerous National Weather Service briefings
      throughout the month, none of which affected the borough
      and/or were significant enough to pass to Borough Council
      (BC).
    - Due to the prospect of extensive flooding/flash flooding, York County OEM initiated Web Emergency Operation Center (WebEOC) Incident 13895 on Monday, July 14 at 9:07 am county wide. Some municipalities made disaster declarations and a York County disaster declaration was made on Tuesday, July 15 at 3:47 pm. Updates continued through July 28 when WebEOC Incident 13895 was closed.

# Meetings/Training:

- Due to the flooding that occurred in other parts of York County in mid July, the York County OEM quarterly EMC Training scheduled for July 16 was rescheduled for Tuesday, August 12 from 6:00-8:30 pm. An Emergency Assistance Coordinator from the Pennsylvania Department of Human Services (DHS) will give an overview on PA-DHS resources, ways they can help at the county/local level and services they can provide (e.g., training or exercises). Further discussions will be cover continuing efforts to identify and sign-on facilities to serve as county shelters and methods to establish shelter agreements at the local level.
- On Thursday, July 17, York County OEM announced the York County Community Emergency Response Team (CERT). The CERT program educates volunteers about disaster preparedness for the hazards that may occur where they live. Additionally, the CERT program offers a consistent, nationwide approach to volunteer training and organization that professional responders can rely on during disaster situations, allowing them to focus on more complex tasks. The first basic training class will be in the winter of 2025-2026. - On Friday, July 18, York County OEM announced a Stakeholder Preparedness Review (SPR) in preparation for submission to the Federal EM Agency. The SPR will be held on Friday, August 22 from 9 am-1 pm at York County OEM.
- The appearance at Magisterial District Court 19-03-04 for two hearings for parking violations during the Snow Emergency Declaration for Winter Storm Freya (February 5, 2025) on Tuesday, July 22 was deferred until August.
- On numerous occasions during the month of July, the BC President and I made visits to various locations throughout the borough to address borough residents' concerns regarding complaints of potential ordinance violations. In some cases, no one was home and on other occasions when performing followup visits, remedies had been made.

# Miscellaneous:

- Per discussions at the July 7 BC meeting regarding rights of way (30 feet on state roads and 15 feet on borough roads), on July 8 I reached out to Grant Anderson, Borough Engineer, to obtain current copies of the PennDOT borough street map which he provided me on July 9 when he was checking progress on Parkview Drive repaving. To date I've surveyed the Parkview West development and have identified approximately a dozen residences which have vegetation that obstructs the sidewalks. I plan on completing borough surveys in the month of August. The next step is to determine how the borough wants to notify residents of necessary corrective actions. At the July7 BC meeting, we learned that the boom mower from Springfield Township would be available at \$85/hour for trimming (e.g., along Reynolds Mill Road/PA 214). Of note on the PenDOT Type 5 map (Rev. 8-7-2024) https://gis.penndot.pa.gov/BPR pdf files/Maps/Type5/66417.pdf, despite the new PSP Barracks being built and occupied at 101 North Main Street for a number of years now, is still displayed at 110 Trooper Court which is presently occupied by Wolfgang Chocolate. Additionally, the portion of Laurel Oak Lane within borough boundaries, with townhouses at 361-422 Laurel Oak Lane, is not depicted on the map.
- Two Verizon telecommunication lines and one MetEd/First Energy power line were found to be only four feet off the ground due to a utility pole guy line failure for Verizon Pole "VZ13" on Loucks Street at the corner of Old Orchard Road and the rear of the Loganville-Springfield Elementary School property. After researching who at Verizon and MetEd/First Energy to contact about their downed lines, I sent an email to them on Friday, July 25 at 10:02 am. The guy line utility pole was restored the same day and the lines are back at their proper height.
