If you could post this on your website or facebook page we would appreciate it. We had a close call in one of our municipalities last week when a resident tried to throw some trash in the compaction area of the truck while our driver was dumping their cart with the automated arm. If the driver hadn't seen this and put the cart down while the resident was standing there throwing the item into the truck, it could have been a life changing or life ending incident.

In a township in South Central PA last week, Republic Services had a resident approach one of their trucks to throw something in the compactor area while our driver was operating the remote mechanical arm to empty the residents cart.

We cannot stress how dangerous this was and we need to express in the most serious way possible that this cannot happen for many reasons with resident safety being the most important. This is especially important to tell your children since school will soon be on summer break.

DO NOT APPROACH A TRUCK THAT IS IN THE ACT OF DUMPING THE CONTAINER INTO THE COMPACTION AREA.

DO NOT ATTEMPT TO GET THE OPERATORS ATTENTION WHILE THEY ARE OPERATING THE COMPACTION MECHANISM OR THE ARM THAT DUMPS THE CARTS

## DO NOT ATTEMPT TO THROW ITEMS INTO THE COMPACTION AREA OF THE TRUCK

The last thing Republic Services or the municipality wants is for a resident to be injured or potentially killed in the process of Republic collecting a residents trash or recycling materials.

Thank you for your attention to this very serious safety concern.
